RE: SUPPLEMENTAL RETIREMENT ANNUITY (SRA) PLAN LIMITS FOR 2020

Please be advised that contribution limits for supplemental retirement annuity (SRA) accounts will **increase** for calendar year 2020. The base maximum deferral amount is \$19,500 for calendar year 2020 in the 401k, 457b, or 403b plans. Employees' age 50 or older may contribute an additional \$6,500 catch-up contribution into a 403b, 457b, or 401k accounts for a total of \$26,000 in the calendar year 2020.

Please be mindful that deferrals to 403b and 401k accounts are **combined** when analyzing contributions against the maximum amounts. For example, an employee with a 403b <u>and</u> 401k accounts may only contribute \$19,500 as a combined total if under 50 and a total pre-taxed deferral of \$26,000 for employees over 50 years of age.

In contrast, deferrals to 457b accounts are counted <u>separately</u> from 403b and 401k contributions. Therefore, employees with a 403b or 401k <u>and</u> 457b accounts can contribute the base maximum of \$19,500 to the 401k/403b AND up to an additional \$19,500 in the 457b for a total of \$39,000. If applicable, the age 50 catch up can be added to both the 401k/403b AND 457b accounts for a total pre-taxed deferral of \$52,000.

To make changes for the first paycheck in January 2020, *originals* of the <u>SRA change forms</u> must be submitted to Human Resources by <u>Thursday</u>, <u>December 12</u>, <u>2019</u>.

Maximum Biweekly SRA Contributions for 26 pay periods, starting the first paycheck of January 10, 2020:

## **Under Age 50:**

**401K/403b** Contributions, over 26 pays (\$19,500/26): **\$750.00** 

**457b** contributions, over 26 pays (\$19,500/26): **\$750.00** 

## Age 50 or Older:

**401K/403b** Contributions, over 26 pays (\$26,000/26): **\$1,000** 

**457b** contributions, over 26 pays (\$26,000/26): **\$1,000**
